1. EXPLANATORY NOTE

1.1 Goals and objectives of the training discipline

The goal of the discipline "Legal fundamentals for sustainable development of agricultural territories" is to form a holistic view of the legal regulation of sustainable development of agricultural territories at the national level, as well as the legal foundations of significant socio-economic transformations in agriculture and the agro-industrial complex associated with the formation of a multi-structured agrarian economy, the emergence of new organizational and legal forms of agricultural activities, the strengthening of state regulation of agrarian relations.

Objectives of studying the discipline:

- to form an idea of the essence and features of legal fundamentals for sustainable development of agricultural territories;
- to acquaint with the basics of legal fundamentals for sustainable development of agricultural territories in the Republic of Belarus;
- study the general regulatory legal acts in the field of agricultural relations in the Republic of Belarus;
- to study the concept and features of agrarian legal relations, the grounds for their occurrence and termination;
- to study the legal and regulatory documents related to public administration and regulation in agriculture;
- to give an idea of the legal regulation of entrepreneurial activity in agriculture;
- to characterize the legal status of agricultural enterprises, peasant (farm) economy.

1.2. The place of training discipline in the system of training of specialists, relations with other training disciplines

The discipline is focused on the study by undergraduates of the features of legal regulation of sustainable development of agricultural territories, taking into account the principles of law and lays down an understanding of the mechanism of legal regulation of agricultural relations, law enforcement practice based on knowledge of the provisions of the current legislation and experience in regulation of public relations.

The development of the discipline is based on the competencies acquired earlier by students in the study of the disciplines "Management", "Marketing", "Fundamentals of Law", "Organization Management"..
